## SUMMARY ANNUAL REPORT FOR UNITE HERE NORTHWEST HEALTH TRUST FUND

This is a summary of the annual report of the UNITE HERE Northwest Health Trust Fund, EIN 91-0590441, Plan No. 501, for period June 1, 2022 through May 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of UNITE HERE Northwest Health Trust Fund (the Plan) has committed itself to pay certain health, death, weekly disability, dental, hearing, and vision claims incurred under the terms of the plan.

## <u>Insurance Information</u>

The plan has contracts with Ameritas Life Insurance Corp, Life Insurance Company of North America, The Union Labor Life Insurance Company and Willamette Dental of Washington, Inc. to pay dental, vision, life insurance, long-term disability, stop loss and accidental death & dismemberment benefit claims incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2023 were \$1,166,430.

Because Willamette Dental of Washington, Inc. is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending May 31, 2023, the premiums paid under such "experience-rated" contract were \$63,015 and the total of all benefit claims paid under the experience-rated contract during the plan year was \$51,941.

## Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$83,105,477 as of May 31, 2023, compared to \$79,010,137 as of June 1, 2022. During the plan year the plan experienced an increase in its net assets of \$4,095,340. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$26,726,645, including employer contributions of \$27,138,388, employee contributions of \$167,747, earnings from investments of (\$1,051,724), and other income of \$472,234.

Plan expenses were \$22,631,305. These expenses included \$1,848,195 in administrative expenses, and \$20,783,110 in benefits paid to participants and beneficiaries.
